<p><b>How much does the CPA exam cost?</b></p>	<p>The total cost includes application and administration fees, in addition to the examination fees. The cost varies for each jurisdiction. For the state of MS, refer to <a href="http://www.msarpa.ms.gov/Pages/Fees.aspx">http://www.msarpa.ms.gov/Pages/Fees.aspx</a> . <p><b>When is the test offered?</b></p>	<p>The CPA exam is offered during every month during a testing Window that varies month to month. These dates can be found at <a href="https://www.aicpa.org/becomeacpa/cpaexam/forcandidates/howtoprepare/sched.html">https://www.aicpa.org/becomeacpa/cpaexam/forcandidates/howtoprepare/sched.html</a></p>
<p><b>Do I need to make an appointment?</b></p>	<p>Candidates must schedule an appointment via <a href="http://www.prometric.com/cpa">www.prometric.com/cpa</a> or their regional call center.</p>
<p><b>How long is the test?</b></p>	<p>The Auditing and Attestation tests (AUD) are allotted 4 hours. The Financial Accounting and Reporting tests (FAR) are allotted 4 hours. The Regulation tests (REG) are allotted 4 hours. The Business Environment and Concepts (BEC) are allotted 4 hours.</p>
<p><b>How long does it take to get my scores back?</b></p>	<p>The release of a candidate's scores are dependent upon the window that the exam was taken. <p><b>What do I need to bring to the test?</b></p>	<p>Bring two forms of identification to your appointment, one of which must contain a recent photograph. Each form of identification must bear your signature and must not be expired. Candidates must bring their NTS (Notices to Schedule) to their appointment. *Student ID is <b>not</b> an accepted form of identification*</p>
